Navy's First Black Captain Dies

WASHINGTON (NNS) -- The Navy's first black Sailor to be promoted to the rank of captain died April 16 in Norfolk.

Funeral services for retired Capt. Thomas David Parham were held April 21, at 1 p.m. at the Little Creek Amphibious Base chapel. The Reverend Dr. Barry C. Black, U.S. Senate chaplain and retired U.S. Navy chief of Chaplains delivered the eulogy.

Parham, 87, was commissioned in 1944 and promoted to captain in February 1966. He was also the second black chaplain in the Navy.

Born March 21, 1920, in Newport News, Va., Parham earned a bachelor's degree from North Carolina Central University in 1941. He then graduated magna cum laude from Pittsburgh Theological Seminary in 1944, and was ordained by the United Presbyterian Church on May 17, 1944.

While five other members of his seminary class entered the Navy chaplaincy upon their graduation, Parham was told his application could not be accepted. He continued to work in a student pastorate in Youngstown, Ohio. Later that summer, he saw a newspaper photograph of a recently commissioned black chaplain. When he returned to the officer who had earlier rejected his application and asked why, he was told, "We can take your application now."

His first duty assignments included Naval Training School, Hampton, Va.; Camp Smalls at Great Lakes, Ill.; Manana Barracks, Hawaii; and the Naval Supply Center, Guam; ministering to exclusively black units.

Parham left active duty in 1946

and returned to his ministry in Youngstown where he served as pastor from 1946 to 1950, while remaining in the Naval Reserve.

He returned to active duty in January 1951, soon after the outbreak of the Korean War. From 1951 to 1956, he was the only black chaplain on active duty.

After he had been given the impression that a black chaplain would never go to sea duty, he married Eulalee Marion Cordice on June 1, 1951.

Subsequently, when he was to be stationed on board USS Valley Forge (LPH-8), a captain complained to the Chaplains Division that Parham would be the only chaplain on the ship while the only black Sailors were a few stewards: The belief that black chaplains were only for black Sailors was predominant. Then Chief of Chaplains Stanton Salisbury published an article in the Christian Century stating that the Chaplains Division had no plans to give Parham any segregated duty, demonstrating the progress made in the Chaplains Division and in the Navy.

Parham's other duty stations included Charleston Navy Yard, S.C.; Fleet Activities Sasebo, Japan; Naval Air Station Iwakuni, Japan; Menninger Foundation, Topeka, Kan.; First Marine Division, Camp Pendleton, Calif.; Amphibious Squadron 1 and Marine Corps Recruiting Depot, San Diego; Naval Air Station and Commander Fleet Air, Quonset Point, R.I.; Bureau of Naval Personnel, Washington; Naval Training Center, Bainbridge, Md.; and Chief, Pastoral Care Service, Naval Region Medical Center, Portsmouth, Va.

In 1969, he earned a Master of Divinity at Pittsburgh Theological Seminary. At American University he

received both a master's and a doctorate degree. Parham retired in April 1982.

- Get close to your subject
- Catch your subject being natural
- Watch your light
- Include foreground
- Background is important, look for poles or wires protruding from your subject
- Be ready
- Shoot off center for effect
- Hold your camera steady
- Be creative
- Try shooting at different angles
- Focus, then focus again

Ground broken for Samuel L. Gravely Elementary School

Several members of the Prince William County community gathered on April 23, 2007 to break ground on the Samuel L. Gravely Elementary School. The school will be named in honor of Vice Adm. Samuel L. Gravely who, among many other accomplishments, was the first African American to reach flag rank in the Navy.

In attendance were Gravely's widow, Alma Gravely, and David Gravely, their son. Members from Mrs. Gravely's church, who were instrumental in initiating the request to name to school after the late admiral, were also in attendance.

A middle school in another area of the county was originally considered to be named in honor of Gravely.

However, because the site for the elementary school was literally in the back yard of the Vice Adm. Gravely's Haymarket home and he took a deep interest in elementary school education, the school board decided to make a rare exception to waive its policy regarding school naming.

When initially contacted about the idea of naming a school after her husband, Mrs. Gravely thought it would be more appropriate to name the school after someone who had resided in Prince William County longer than the Gravelys. Martha Henley, who contacted Mrs. Gravely, replied "but they are not admirals." Mrs. Gravely gave her approval for community members to move forward with the request, but she did not actively participate in the process. She wanted to know that the school board's decision was based on what the county wanted and not her involvement.

Rear Adm. Vic Guillory was on hand to represent the Navy. He first met Gravely when Gravely was a captain and Guillory was an enlisted sailor. Guillory commented that Gravely "commanded a presence."

"He inspired me," said Guillory, "and gave me an opportunity to dream."

He hopes that Gravely Elementary School will inspire the students who attend and that some will join the Navy. Guillory also hopes that the students will do great things in the community and across the nation.

Also in attendance was the Gainesville District School Board Representative Donald Richardson, who is a neighbor of the Gravelys.

"This is important because Gravely was a role model,"

Richardson said. "This is not just about education and textbooks. He was a man who broke barriers. We are honoring his legacy."

Construction on the 17.9-acre school site began in January 2007. The school will open in September 2008.

Photograph now required for Navy officer service record

The Navy Bureau of Personnel recently announced that photographs are required for all officers of the Navy and the Navy Reserve, regardless of status, within 3 months after acceptance of each promotion.

The photographs submitted become the property of the United States Navy and are generally releasable under the Secretary of the Navy Instruction 5211.5E, Department of the Navy Privacy Act Program and Secretary of the Navy Instruction 5720.42F, Freedom of Information Act Program.

Per Navy Personnel Instruction 5665I, U.S. Navy Uniform Regulations reference), the preferred uniform shall be Service Khaki, uncovered. When Service Khaki is unavailable, any regulation uniform is acceptable.

The photograph shall:

- be in color
- display a full-length, three-quarter view of the member, left shoulder forward
- have a plain, flat background to provide sufficient contrast to highlight details of the uniform
- be 4 inches in width and 6 inches in height.

Title board specifications require a menu or hand-lettered title board that shall be placed at or near the member's left foot so it is clearly readable in the finished photograph.

The title board shall contain the following identifying data in 2-inch high letters:

- Member's last name, first name and middle initial(s).
- Grade, last four digits of the social security number, and designator.
- Date photograph was taken (day, month, year).

Naval activities with an established photographic facility are

authorized to produce photographs for this purpose. Additionally, commercial sources are authorized. When Navy or Department of Defense photographic facilities or suitable commercial sources are unavailable, any photograph that complies with the requirements will be accepted.

Commands are authorized to reimburse officers that use commercial sources to produce photographs.

Commands are authorized to reimburse officers for the cost of the official photograph. Officers will complete SF 1164 (Rev. 11-77), Claim for Reimbursement for Expenditures on Official Business, or similar reimbursement document and submit the form with official documentary evidence (e.g., receipts, affidavits, or other statement as to the unavailability of government photo facilities) to their commanding officer (or designated representative) for approval and reimbursement.

Officers are required to complete NAVPERS Form 1070/884 (04-07), Officer Photograph, and attach the unaltered photograph. The preferred method of attachment is to print the photograph directly on the form. Taping or stapling the photograph to the form is acceptable should printing directly on the form not be available. Ensure this form contains the member's complete social security number for Official Military Personnel File (OMPF) identification purposes.

The member must sign the form, carefully secure the photograph against damage in the mail and forward to Navy Personnel Command (PERS-312C) for inclusion in the OMPF. The complete mailing address is:
